

Cabot Corporation to Increase Prices on Specialty Carbons Products in Americas and EMEA Regions

March 8, 2021

BOSTON – Effective for all shipments on or after April 5, 2021, or as contracts allow, <u>Cabot Corporation</u> will increase prices up to 8 percent in the Americas and Europe, Middle East and Africa (EMEA) regions for specialty carbon black products. These price increases are necessitated by the significant and rapid increases in costs including raw material, transportation and logistics, and operational costs across all products and regions. The increase will help ensure that Cabot remains a reliable, long-term supplier of high-quality products and services. It will also enable continued investment in the development of new products and applications to support customers.
