- On July 13, 2007, Cabot's Board of Directors declared a dividend of \$.18 per share on Cabot common stock, payable on September 14, 2007 to all holders of record of common stock on August 31, 2007. Mr. McCance received a dividend on his phantom stock units totalling \$309.83, which was immediately reinvested in phantom stock units at a price of \$37.53 per share. As a result, 8,255 phantom stock units were allocated to Mr. McCance on September 14, 2007.
